Sir,

This has reference to Appeal dated 20-08-2016 filed by you against the decision of NBA for not granting accreditation to Post Graduate Diploma in Management program of your Institute communicated vide NBA's letter of even number dated 02-08-2016.

2. The Appeal was considered by the Appellate Committee of NBA in its meeting held on 18-11-2016. The recommendation of the Appellate Committee was considered by the Competent Authority in NBA. Based on the decision taken, accreditation status of the program is given in the table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to International Management Institute, IDCO Plot No 1, Village-Gothapatna, PO-Malipada, Bhubaneswar-751003 Dist-Khurda, Odisha as a whole. **As such the Institution should nowhere along with its name including on its letter head etc., write that it is accredited by NBA because it is programs accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.** Complete name and level of the program accredited and the period of validity of accreditation, as well as the date from which the accreditation is effective, should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.

If there are any changes in the status (major changes of faculty strength, organizational structure etc.), the same are required to be communicated to the NBA, with an appropriate explanatory note.
