**RECORD NOTES OF THE 30TH MEETING OF SCHEME STEERING COMMITTEE (SSC) OF
SFURTI CHAIRED BY SECRETARY (MSME) ON 24TH JULY, 2019**

Director (ARI) welcomed the participants to the meeting. The agenda points were then taken up for consideration. The list of participants is annexed at **Annexure**.

1. **Agenda Item No.1: Confirmation of Minutes of the 29th meeting of the SSC:** Minutes of the 29th meeting of the SSC held on 21.02.2019 were noted and confirmed.
2. **Agenda Item No.2: Action taken report on the decisions taken in the 29th meeting of the SSC:** As per directions of the last SSC, all Nodal Agencies were asked to review the progress and ensure timely completion of the implementation of clusters within stipulated timelines.
3. **Agenda Item No.3: Status of SFURTI Clusters:** Director (ARI) presented a snapshot of the 142 [72+70] approved projects under SFURTI and the progress made by each of the Nodal Agencies till date. Ministry of MSME has a mandate to reach out to the 117 aspirational districts and under SFURTI, special care has been taken to bring credible proposals from these districts.
4. **Agenda Item No.4: To consider for final approval 45 DPRs received from KVIC (6), IIEG (8), Coir Board (10), IED Odisha (10), NIMSME (5) & IMEDF (6):**

I. **Final approval of DPRs:** A brief snapshot of each proposal is given as below:

A. **KVIC**

(i) The **Reiek Multi Farming Cluster, Mamit, Mizoram** has been presented for approval under SFURTI. It was submitted by the Technical Agency (TA) that the project would provide higher value addition and returns. The Committee examined the proposal and found it suitable for intervention under SFURTI in the aspirational district of Mamit. **The proposal was approved.**

(ii) The **Athani Leather Cluster, Belagavi, Karnataka:** This intervention through SFURTI is an attempt to bring the existing artisans into the value chain and provide them an opportunity to improve and diversify the product and raise the marketability of products. **The cluster caters to artisans dedicatedly belonging to Scheduled Castes. The proposal was approved.**

(iii) The **Pandit Deen Dayal Upadhyay Tribal Womens Bibba Processing Cluster, Malegaon, Washim District** is a unique attempt to reach out to the substantial tribal population involved with the collection and processing of various traditional products in the region. It is one of the proposals from the aspirational district from Maharashtra. The cluster caters to artisans dedicatedly belonging to Scheduled Tribes. **The proposal was approved.**

(iv) The **Cane & Bamboo Cluster, Navsari, Gujarat** is an attempt to provide a bamboo based processing cluster at the countryside close to the production base so as to provide the farmers an opportunity to realize their full potential. Secretary, MSME, urged the TA to increase the coverage by enrolling more number of artisans into the cluster. **The proposal was approved with the direction to the NA to increase the artisan base.**

(v) The **Foot & Floor-mat Cluster, Thiruvananthapuram, Kerala** is an attempt to provide a unique herbal-based floor mat being used for yoga and other naturopathy procedures. As it uses multiple based processing cluster at the countryside close to the production base so as to provide the farmers an opportunity to realize their full potential. Secretary, MSME, urged the TA to increase the coverage by enrolling more number of artisans into the cluster. **The proposal was approved.**

(vi) The **Holagarh Embroidery Craft Cluster, Allahabad, Uttar Pradesh** is an attempt to provide embroidery cluster at the countryside close to the production base so as to provide the farmers an opportunity to realize their full potential. Secretary, MSME, urged the TA to increase the coverage by enrolling more number of artisans into the cluster. **The proposal was approved.**

B. Coir Board

(i) The **Kuddaluru Coir Cluster, Mandya, Karnataka** was presented before the Committee. The HI cost was rationalized to Rs.349.67 lakh under SFURTI grant in view of 'electrical cabling, transport vehicle', which are not supported under the scheme. **The proposal was approved** with a view to enhance capacity for value addition in coir pith manure.

(ii) The **Kortagere Coir Cluster, Tumkur, Karnataka** was presented before the Committee. Among 825 artisans, majority of artisans belong to Scheduled Caste. The HI cost was rationalized to Rs.385.88 lakh under SFURTI grant in view of 'electrical cabling, transport vehicle', which is not supported under the scheme. **The proposal was approved** with a view to enhance capacity for value addition in coir geo-textile, pith block and pith manure.

(iii) The **Cheluru Coir Cluster, Tumkur, Karnataka** was presented before the Committee. All 800 artisans belong to Scheduled Caste. The HI cost was rationalized to Rs.346.99 lakh under SFURTI grant in view of 'electrical cabling, transport vehicle', which are not supported under the scheme. **The**

proposal was approved with a view to enhance capacity for value addition in pith block and pith manure.

(iv) The **Shri Ganganathswamy Coir Cluster, Tumkur, Karnataka** was presented before the Committee. The HI cost was rationalized to Rs.367.20 lakh under SFURTI grant in view of 'electrical & accessories', which is not supported under the scheme. **The proposal was approved** with a view to provide tufted mat production facility in Karnataka.

(v) The **Amlapuram Coir Cluster, East Godavari, Andhra Pradesh** was presented before the Committee. Most of the members are women with 30% of them belonging to Scheduled Caste & Scheduled Tribe category. The HI cost was rationalized to Rs.246.99 lakh under SFURTI grant in view of 'electrical & accessories, office furniture and preliminary expenses', which is not supported under the scheme. **The proposal was approved.**

(vi) The **Kadiyapulanka Coir Cluster, East Godavari, Andhra Pradesh** was presented before the Committee. The HI cost was rationalized to Rs.305.17 lakh under SFURTI grant in view of 'office furniture and preliminary & pre-operative expenses', which is not supported under the scheme. Secretary, MSME, asked the TA to provide Aadhaar numbers of artisans to verify the involvement in cluster development. **The proposal was approved.**

(vii) The proposals pertaining to Tamil Nadu (2) [*Sri Jayam (Karur) Coir Cluster-Karur & Western Ghats Coir Cluster-Virudhnagar*] and Karnataka (2) [*Servagarana Coir Cluster & Shiddankatte Coir-Tumkur*] **were deferred for sorting out certain specific issues by the Coir Board.**

C. IIE Guwahati

(i) The **Dokra Craft Cluster, Purba Burdhan, West Bengal**: The proposal was presented before the Committee. Secretary, MSME, urged the TA to increase the coverage by enrolling more number of artisans into the cluster. The NA confirmed that the number of artisans would increase to 650 at the end of 1st year 820 at the end of 2nd year of implementation. The Chair also focused on tying up with export houses for high value market. The high cost of furniture & health camp can't be supported under the scheme, hence the Hard Intervention rationalized to Rs.115.94 lakh. **The proposal was approved.**

(ii) The **Fashion Accessories Cluster, Tatarpur, West Midnapore, West Bengal**: The proposal was presented before the Committee. Secretary, MSME, urged the TA to increase the coverage by enrolling more number of artisans into the cluster. The number of CAD centres(4) has been limited to 1 CAD centre. Thus the cost under the Hard Intervention is rationalized to Rs.117.05 lakh. The cost of health camp under the SI can't be supported. **The proposal was approved.**

(iii) The **Cane & Bamboo Cluster, Chandel, Manipur** is an attempt to provide a bamboo processing cluster in the aspirational district. **The proposal was approved.**

(iv) The **Kaliabor Silk Cluster, Assam** is an attempt to reach out to the rich tradition of silk and handicraft products. **The proposal was approved.**

(v) The **Eri Silk Cluster, East Siang District, Arunachal Pradesh**, is an attempt to reach out to the rich tradition of silk and handloom based products. **The proposal was approved.**

(vi) The **Dhemechi Organic Green Tea Cluster, Dibrugarh District, Assam** was presented. This is a unique attempt to provide value addition to tea growers in the region. **The proposal was approved.**

(vii) The **Naharbari Tea Cluster, Sonitpur, Assam** was presented. This is a unique attempt to provide value addition to tea growers in the region. **The proposal was approved.**

(viii) The **Cane & Bamboo Based Furniture & Utility Product Cluster, Tamenglong, Manipur** was presented. The proposed 5 production units need to be rationalized to 3 units to save spreading of resources for construction of physical infrastructure. Hence, the HI cost is rationalized to Rs.179.83 lakh. **The proposal was approved.**

D. IEDO

(i) The **Bahugram Jute Cluster, Cuttack** was presented before the Committee. Secretary, MSME, urged the TA to increase the coverage by enrolling more number of artisans into the cluster. The HI cost was rationalized to Rs.155.29 lakh under SFURTI grant in view of 'DG set' and 'Contingency charges', which are not supported under the scheme. **The proposal was approved.**

(ii) The **Dhanakera Applique Cluster, Puri** was presented before the Committee. Secretary, MSME, urged the TA to increase the coverage by enrolling more number of artisans into the cluster. The HI cost was rationalized to Rs.166.93 lakh under SFURTI grant in view of 'land development' and 'Contingency charges', which are not supported under the scheme. **The proposal was approved.**

(iii) The **Kalyani Jute Cluster, Balasore** was presented before the Committee. Secretary, MSME, urged the TA to increase the coverage by enrolling more number of artisans into the cluster. The HI cost was rationalized to Rs.144.01 lakh under SFURTI grant in view of 'DG set', which are not supported under the scheme. The proposal has discrepancy in terms of the outcome of the project intervention. **The proposal was approved.**

(iv) The **Bee-wax & Honey Processing Cluster, Daspallah, Nayagarh** was presented. The 550 artisans presently covered in the cluster are all women. The entire cost has been rationalized accordingly. **The proposal was approved.**

(v) The **Udala Weaving Cluster, Mayurbhanj** was presented before the Committee. Secretary, MSME, urged the TA to increase the coverage by enrolling more number of artisans into the cluster. The HI cost was rationalized to Rs.117.00 lakh under SFURTI grant in view of 'contingency', which is not supported under the scheme. **The proposal was approved.**

(vi) The **Bhatimunda bell metal cluster, Cuttack** was presented before the Committee. Secretary, MSME, urged the TA to increase the coverage by enrolling more number of artisans into the cluster. The HI cost was rationalized to Rs.225.55 lakh under SFURTI grant in view of 'land development & contingency', which are not supported under the scheme. **The proposal was approved.**

(vii) The **Vegetable & Food processing cluster, Dhenkanal** was presented to the SSC. The HI cost was rationalized to Rs.414.38 lakh under SFURTI grant in view of 'land development', which is not supported under the scheme. **The proposal was approved.**

(viii) The **Urnati Jute Cluster, Puri, Odisha** was presented before the Committee. This is a 100% women artisan based cluster. The HI cost was rationalized to Rs.114.10 lakh under SFURTI grant in view of 'DG set & Insurance', which are not supported under the scheme. **The proposal was approved.**

(ix) The **Bamunda Mahua Cluster, Sundargarh, Odisha** was presented. This is a unique cluster approach to create value addition in Mahua flower based products. The HI cost was rationalized to Rs.221.99 lakh under SFURTI grant in view of 'contingency', which is not supported under the scheme. **The proposal was approved.**

(x) The **Paper Mache Cluster, Keonjhar, Odisha** has been presented before the SSC. The HI cost was rationalized to Rs.89.11 lakh under SFURTI grant in view of 'production unit (2)', which is not supported under the scheme. **The proposal was approved.**

E. NIMSME

(i) The **Sus Cotton Cluster, Pune** was presented before the SSC. The cluster is an attempt to provide garmenting facility in a huge scale to provide livelihood to 1055 women. The HI cost was rationalized to Rs.352.80 lakh under SFURTI grant in view of high cost of 'electrical installation', which is not supported under the scheme. **The proposal was approved.**

(ii) The **Honey Processing Cluster, Lohardagga, Jharkhand** was presented. The HI cost has been rationalized to Rs.108.23 lakh under SFURTI grant in view of cost of 'land development, showroom facility & miscellaneous fixed assets', which are not supported under the scheme. The NA has promised addition of 200 new artisans by the end of completion of the project. The IA is contributing more than mandatory 10% along with contribution to soft intervention. **The proposal was approved.**

(iii) The **Gold & Silver Jewellery Cluster, Sukrighraha, Ramgarh, Jharkhand** was presented. The HI cost has been rationalized to Rs.243.86 lakh under SFURTI grant in view of high cost of 'land development, showroom facility & miscellaneous fixed assets', which are not supported under the scheme. The NA has promised addition of 200 new artisans by the end of completion of the project. **The proposal was approved.**

(iv) The **Bundu Lac Farming & Processing Cluster, Ranchi, Jharkhand** was presented. The HI cost has been rationalized to Rs.405.00 lakh under SFURTI grant in view of cost of 'land development, showroom facility & electrification', which are not supported under the scheme. **The proposal was approved.**

(v) The **Mangaon Bamboo Processing Cluster, Sindhudurg, Maharashtra** was presented. The HI cost has been rationalized to Rs.139.16 lakh under SFURTI grant in view of high cost of 'electrification & miscellaneous fixed assets', which are not supported under the scheme. **The proposal was approved.**

F. IMEDF

(i) The **Lac and other NTFP Processing Cluster, Gumla, Jharkhand** was presented before the Committee. The Committee emphasized the importance of design intervention and making products for export market to ensure quality of the products of the cluster. **The proposal was approved.**

(ii) The **Sagara Woodcrafts Cluster, Shivamoga, Karnataka** was presented before the Committee. Secretary MSME instructed the NA to ensure new designs and patterns be amalgamated to the existing production. **The proposal was approved.**

(iii) The **Mohanpur Millet Magic Cluster, Mayurbhanj, Odisha** was presented. The HI cost has been rationalized to Rs.355.57 lakh under SFURTI grant in view of cost of 'miscellaneous equipment & renewable power source', which are not supported under the scheme. The Chairman SSC raised a concern that State Governments must put in funds for bigger clusters on a regular manner. However, this proposal was **approved with a direction** to get the entire cost of machinery vetted from an agency dealing with food processing or technology for such machinery, so that the effective machinery can be bought for the cluster.

(iv) The **Agribusiness Cluster, Kiphire, Nagaland** was presented. This is a proposal in the far flung aspirational district in Nagaland. **The proposal was approved.**

(v) The **Udala Palmaroja Cluster, Mayurbhanj, Odisha** was presented. The cost of generator worth Rs.11.80 lakh cannot be supported as per Guidelines. However, this proposal was **approved with a direction** to get the entire cost of machinery vetted from an agency dealing with herbal and medicinal plants extract such as CIMAP or FFDC, Kannauj, so that the effective machinery can be bought for the cluster. The cost has been rationalized accordingly. **The proposal was approved.**

(vi) The **Tijara Fruits & Vegetables Cluster, Alwar** was presented. The committee considered the proposal and noted that some technical agency should certify the price and quantity of machines/equipments proposed under the DPR. Committee also desired that NA should get the proposal appraised from M/o Food Processing Industries, Govt. of India, New Delhi relating to the processing of fruits and vegetables proposed in the DPR. The proposal was accordingly deferred.

10. Agenda No.10: To consider ratification of appointment of Shri Ravi Dubey (from 23.3.2019 to 04.01.2020) and Shri Avinash Kumar (from 23.3.2019 to 31.07.2019) as Sr. Programmers under NIC from SFURTI administrative fund in M/o MSME.

Shri Ravi Dubey and Shri Avinash Kumar were engaged as Senior Software Developer in this Ministry through NIC with the concurrence of the IF wing and approval of Secretary, MSME for development and maintenance of SFURTI portal during 2018-19. Their tenure ended on 22.3.2019. As development and maintenance of SFURTI portal is a continuing process, hence, it was proposed to continue their services beyond 22.3.2019 and the proposal was approved by Secretary (MSME) and concurred by IFW on file on 14.6.2019.

The SSC approved the extension of services of Shri Ravi Dubey (from 23.3.2019 to 04.01.2020) and Shri Avinash Kumar (from 23.3.2019 to 31.07.2019) as Sr. Programmers.

11. Agenda No.11: To consider extension of tenure of Shri M. L. Sharma (Consultant), KVI-I Section (for SFURTI Scheme) in M/o MSME from 01.10.2019 to 30.09.2020.

Shri M. L. Sharma (retired Under Secretary of this Ministry) was appointed as consultant for SFURTI in this Ministry with the concurrence of IFW and approval of SSC & Secretary, MSME. He has been working as Consultant in the Ministry since 01.10.2015. His services have been excellent. As his tenure is coming to an end on 30.9.2019, it is proposed to continue his services beyond 30.9.2019 for 1(one) year till 30.09.2020 under GFR Rule 2017 Rule 194 (iv) with existing monthly remuneration of Rs.45,000/- (Rupees Forty five thousand only) from SFURTI Scheme Administrative Fund available with the Ministry. There is tremendous workload w.r.t. implementation & monitoring of proposals under SFURTI Scheme and shortage of trained manpower in SFURTI Cell. **The SSC considered and approved the proposal.**

12. Agenda No.12: To consider request of SFURTI Cell in the Ministry for purchase of Office equipments etc. from SFURTI Administrative Fund of SFURTI Scheme.

To meet the requirement of printing of proposals received under SFURTI & photocopy & scanning of documents, a new heavy-duty photocopier machine is required in KVI-I Section (SFURTI Cell) of the Ministry. The existing machine provided is shared with other section and is also old and obsolete & not working properly. Further, in order to make presentation in the SSC meetings and to keep the record of presentation made during the meeting, a laptop is required for KVI-I Section (SFURTI Cell). Also, officials of the Ministry also go on inspection/visit of approved clusters as and when directed by Senior Officers. The proposed laptop shall also be useful on such visits for making tour reports. **The SSC was convinced of the need for the above mentioned items and approved the proposal for purchase from Administrative Fund of SFURTI Scheme through GeM Portal and GA Section of the Ministry.**

13. Agenda No.13: To consider appointment of all TCs and Tool Rooms (under the O/o DC (MSME) as Nodal Agencies under SFURTI Scheme.

With a view to increase reach of SFURTI across the country, there is a need to increase the number of Nodal Agencies to implement and monitor SFURTI projects. In order to promote/provide employment opportunities for local traditional artisans/workers, a decision has been taken in the Ministry that all Technical Centres (TCs) and Tool Rooms under the administrative control of O/o DC(MSME) be also designated to act as Nodal Agency under the SFURTI Scheme besides existing 8 Nodal Agencies, **which was ratified by the SSC.**

14. Agenda No. 14: Any other matter with the permission of the Chair.

A. Matter relating to J&K KVIB – Kasur Manch, Beekeeping Cluster, Srinagar – As requested by the NA to change the location of CFC & revision of financials of the proposal, the SSC approved with revised financial outlay for the project as follows:

B. Representative of KVIC presented following matters in the Meeting:

i) Koderma Agarbatti Cluster, Jharkhand: KVIC Explained that Koderma Agarbatti Cluster sanctioned in favour of DRDA, Koderma, IA and IL&FS as TA are not showing interest to complete the cluster. The issue was discussed with the Secretary Industry, Jharkhand Govt. in the SSC. He suggested that IA and TA to be changed to Mukhyamantri Laghu Kutir Udyam Vikas Board (MLKUVB) and Jharkhand Industrial Infrastructure Development Corporation (JIIDCO) respectively. Further, he suggested changing some machinery like Hand Operated Agarbatti Making Machine to Power Driven Agarbatti Machine etc. and extra funds required for the same will be met out by the Govt. of Jharkhand. **SSC, Considered the request of KVIC and suggestion of Secretary Industries, Jharkhand Govt. and permitted the proposed changes.**

ii) Mirzapur Hand knotted Carpet, UP: KVIC explained that as Mirzapur Hand Knotted Carpet Cluster could not be implemented as IA has not deposited its share. Thus, KVIC has proposed to change the existing IA namely Jan Kalyan Sansthan with Shiv Devi Vikas Samiti, and revised DPR as per new SFURTI Guidelines. **Committee agreed the proposals and directed for speedy implementation of the project.**

iii) Krishnagiri Multi Food Products Cluster, Tamil Nadu: As KVIC has not specified any alternate Implementing Agency, the proposal was deferred to be examined on file on receipt of detailed proposal for such change. KVIC is required to examine suitability of the Implementing Agency to take the project forward expeditiously.

C. Secretary MSME emphasized the importance of setting up clusters for bringing economies of scale to production; create national and international value chain. Certain specific directions were given as follows:

- i. KVIC to make a list of all crafts, arts, activities and traditional methods adopted across the country with proper mapping of artisans;
- ii. Every product must come with a unique story for attracting customers in the high end markets;
- iii. Peer review by clusters must be encouraged for cross learning and knowledge sharing;
- iv. Independent experts must be encouraged to visit clusters and perform gap analysis;
- v. All Nodal Agencies must make sincere efforts to visit all the clusters under their intervention and submit report within one month.

D. The Chairman of SSC advised that a full-fledged third party evaluation of the clusters needs to be conducted and the outcomes be placed before the SSC. The study would bring out the actual difficulties, challenges and potential course correction, which is to be adopted for faster grounding of projects, providing market linkages and for exploring the export potential of the clusters.

E. All Nodal Agencies must endorse the proposals presented before the SSC and take ownership of the claims of higher production, turnover and increase in wages. Further, it must be ensured that no information should be concealed from the SSC or not provided through the DPR. Moreover, Nodal Agency must fully satisfy itself that techno-economic feasibility of the cluster has been done before placing the same to the SSC. Nodal Agency in consultation with the Technical Agency must make all efforts to make the cluster a success.

F. All clusters focusing on ensuring market access through innovative means and also introducing best practices in terms of technology introduction and having potential export plan for future with concrete steps may be preferred for selection.

G. All 117 aspirational districts, North Eastern Region, SC/ST dominated districts must be targeted to take up clusters on priority by all the Nodal Agencies.

H. State Governments must be encouraged and approached to finance and handhold clusters coming out in their respective areas.
